VENTURA CITY OF THE DEAD SURROUNDED BY LIVING.

Town Trustees Will Take Action to Remedy the Trouble—County Roads in Poor Condition—Cattle Thieves Plead Guilty to Charge.

VENTURA, Jan. 13.—The overcrowding of the Ventura Cemetery is again agitating the people. The cemetery, when first laid out, was nearly a mile Since the town ward the east the dead is all from the town proper.

when first laid out, was nearly a mile from the town proper. Since the town has grown rapidly toward the east until now the city of the dead is all built about by a city of the living. The cemetery has but little more room for the depositing of bodies unless a great wash, or barranca, which runs through its center is filled up, and the question of doing this was discussed by the town trustees last night. With the filling of this ditch accommodations for many more bodies could be had. But there is a difference of opinion as to whether it would be advisable to fill the ditch. Mayor Lewis does not think the plan would be advantageous, as it would take the filled ground too long to settle. His idea is that the cemetery should be moved further eastward and back toward the hills, where a good-sized tract of land could probably be secured. It is not known just what steps will be taken in the premises, but it is evident that something will have to be done at an early date, as the cemetery is really becoming crowded.
